




Figure 1- City Geologist Nick Lawhon led the sinkhole repair on Single Tree Way. He also explained basic karst features and sinkhole remediation techniques to the press. (11 September). Major sinkhole repairs were completed by 30 September.




Figure 3- Operations Hours (July-September)



- Wavetronix for Gary Farms and Scottsville Rd Signal-Staff has coordinated with KYTC to upgrade the radar detection at this intersection, which includes two city maintained approaches. By replacing loops (in the pavement) with radar, we can help reduce future need to replace and/or repair due to utility cuts and overlay activities. Equipment is on order.
- River Street Pedestrian Bridge Update Intech completed all repairs on the corroded areas discovered during the cleaning of the bridge. All work including painting is now complete.
- Oldstone HOA Collaboration On 10 September, Construction Coordinator I Dara Price and Environmental Compliance Inspector Courtenay Howell attended the the HOA meeting. Topics included increased collaboration with the city regarding stormwater issues, bridge maintenance and construction permits.
- Warren County Water District Water Main and Force Main **Expansion to Transpark -** Staff has reviewed specifications and worked closely with WCWD's engineer to obtain all permitting and traffic impacts for the upcoming construction which will affect various roadways on the north side of town. Construction is expected to begin in October.

Environmental Compliance Update

<u>Single Tree Sinkhole Repair</u>- This sinkhole repair is the model for how years of budget oriented repairs ultimately drive costs up. This sinkhole has recurred numerous times over the last decade and due to the difficulties of the repair has been treated with stop gap measures. This most recent repair was necessitated by collapsing soils <u>beneath</u> the prior repairs. Thus all of the previous attempts had to be removed to allow for a proper repair. The work displaced the residents of the nearest home for over two weeks. The excavation disrupted all of the neighborhoods utilities and reached a size of 50' across and over 35' in depth in order to allow for rock fill resting near bedrock to be placed to support the repaired infrastructure including the road. The repair has taken a month to complete and the costs are near \$100,000.

Streamside Field Day was held at Romanza Johnson Park on September 25 with 6th grade students from Alvaton and Jody Richards. The kids participate in a number of field activities. Each activity station is operated for approximately 25 minutes, by practicing professionals. Stations include basic water chemistry and physical indicators; benthic macroinvertebrate collection methods, identification, and tolerance indices; fish collection, identification, and tolerance indices; riparian vegetation and wastewater treatment concepts; and a game that demonstrates the impact of non-point source pollution of aquatic flora and fauna.




Figure 12- Unit 3229 (2016 Dodge Charger Police RWD) required quarter panel, trunk lid and rear lamp work. This is an example of the daily wear and tear on city vehicles. Repair cost was \$1,846 (12 September)


