

Traffic Safety Update- Our Public Works Operations crews and Planning & Design staff installed new flexible delineator posts on Ken Bale Boulevard (in front of Drake's Restaurant). The posts are designed to assist drivers in making safe turns at designated locations. Each post is plastic with reflectors and costs \$53.00. (9 January)



Operation: <u>Providing Adequate Wooden Shelters</u> (PAWS)--Brrr...It's cold outside! The city was able to secure a \$10,000 donation for the purchase of dog house shelters to provide to the financially disadvantaged in our community. To date over 60 dog houses have already been delivered, which the NCS staff has been building and will be delivering to those in need.

**Cave Mill Road corridor project**- The project design consultant provided the preliminary exhibits to show the roadway alignment, proposed multi-use path, roundabout details, storm infrastructure and other proposed improvements to the roadway. Along with the exhibits, property impacts were identified. Staff first met with owners one-on-one that were most significantly impacted and then on 23 January held a public meeting to share the project details and answer questions adjacent property owner may have. Updates on the project timeline, details and funding will continue to be posted on the city's website at https://www.bgky.org/publicworks/cave-mill-improvements.

**Punch list inspections** were conducted for sections 18 & 19 in Greystone Subdivision and for the cul-de-sac completion on Technology Way in the Transpark this month, reviewing the workmanship of the completed developments prior to acceptance for City maintenance. Construction Coordinators completed 227 site inspections and issued 5 notices of violation (NOV). The NOV's were for housing developments and addressed issues with site maintenance and grading/drainage concerns.

<u>Highland Way Greenway project</u>- In-house design is wrapping up and staff has been working closely with our legal department and Arnold Real Estate Consulting, LLC to begin the work necessary to make offers for necessary easement purchases for the project. Overall, property impacts were kept to a minimum as the majority of the path is city right-of-way.

<u>**Transportation Planning efforts</u>** - Staff continues to provide key input in the MPO's update of the 2050 Bowling Green- Warren County Metropolitan Transportation Plan. We have held various public engagement events and exercises and the consultant intends to engage with the MPO Technical Advisory Committee (TAC) at the next meeting on 24 February. 

<u>New Community Trash Cans</u>- A series of 5 side loader serviceable trash cans have taken the place of some older cans in the downtown area. This is in an effort to continue the City's litter abatement efforts. As garbage trucks transition to more efficient technology, the new cans are easier to empty.

**BOC Stormwater Presentation**- On 30 January, ECD Manager Matt Powell and City Geologist Nick Lawhon presented an update on the current status of the city's stormwater infrastructure to the Board of Commissioners. The presentation included a video highlighting the rapid deterioration of key underground infrastructure and the need for a dedicated funding apparatus. A subsequent working meeting will refine the presentation and offer a way ahead for BOC approval.







**Above**- City Geologist Nick Lawhon assesses a sinkhole on Single Tree Way utilizing electrical resistivity tomography (13 January).
