MINUTES of REGULAR MEETING of the BOARD of COMMISSIONERS of the CITY of BOWLING GREEN, KENTUCKY held August 6, 2024

The Board of Commissioners of the City of Bowling Green, Kentucky met in regular session in the Commission Chamber of City Hall, Bowling Green, Kentucky at 4:30 p.m. on August 6, 2024. Mayor Todd Alcott called the meeting to order. Commissioner Sue Parrigin provided the invocation and all present recited the Pledge of Allegiance. City Clerk Ashley Jackson called the roll, and the following members were present: Commissioner Dana Beasley-Brown, Commissioner Melinda Hill, Commissioner Sue Parrigin, Commissioner Carlos Bailey and Mayor Todd Alcott. There was a full quorum of the Board of Commissioners.

PUBLIC HEARING

Assistant City Manager/Chief Financial Officer Katie Schaller-Ward conducted a public hearing for the purpose of obtaining comments from residents regarding the proposed 2024 property tax rates. She reported total real estate property growth was 8.3%, with existing property growing by 4.6% and new property growth at 3.7%. Ms. Schaller-Ward explained it was a requirement to hold a public hearing when the rate is set between the compensating rate and a rate with a 4% increase. She recommended the 2024 real property tax rate be slightly lowered from \$0.205 to \$0.204 and personal property tax rate at \$0.205. There was some history of the new, existing and total growth rates of real property values provided, as well as comparisons of revenue calculations for Fiscal Year 2024, and the average Kentucky tax rates. The property taxes are due December 31, 2024, with a 10% penalty to be applied beginning on January 1, 2025. Since it was a public hearing, Schaller-Ward inquired if anyone from the public wished to speak on the issue. With no further comments, the public hearing was closed.

City Manager Jeffery B. Meisel reminded the audience to sign-up in the back of the Commission Chamber in order to speak during public comments.

A closed session was requested for the purpose of deliberations on the future acquisition of real properties by the City, as publicity would likely affect the value of specific pieces of properties to be acquired by the City.
