Meisel reviewed the Provision of Residents against Drugs (RAD) Police Officer Agreement with the Housing Authority of Bowling Green and stated the agreement presented included updated terms to increase the contribution of the Housing Authority for the salary and fringe benefits of the RAD officer over the next four (4) years to an amount of \$66,000 plus a cost-of-living adjustment to maintain the 50% salary and benefits discount for non-profits. Following a question from Commissioner Beasley-Brown regarding concerns about the increased rate and whether the Housing Authority could allocate the Fiscal Year 2028 rate of \$66,000, Katie Miller of the Housing Authority stated the Housing Authority did not have the ability to obtain additional funding from the Department of Housing and Urban Development (HUD). It was possible funding would have to be reallocated from another program. Mayor Pro Tem Parrigin asked if the Housing Authority was able to increase rent rates and Ms. Miller stated HUD sets the rate but the Housing Authority was currently charging 80% of the set rate, and the process requires HUD approval and takes multiple years. Commissioner Bailey asked if a different rate could be set or if the timeline could be increased from four (4) years to six (6) years. Police Chief Michael Delaney stated 50% was the rate set for non-profits and that four (4) years was the term agreed upon by both parties.

Following concerns from Commissioner Beasley-Brown over the potential of the Housing Authority cutting programs, a motion was made by Beasley-Brown and seconded by Bailey to postpone Municipal Order No. 2024-160 to the August 6, 2024 Board of Commissioners meeting. A roll call vote was taken.
